

### ACCEPTABLE FORMS OF PAYMENT:

- Credit/Debit Cards—VISA, MasterCard, Discover
- Prepaid cards that have a verifiable United States address
- Cashier's check

We do not accept personal checks and will return them to the sender. Credit/debit and prepaid cards will be charged on the day the order is placed. Refunds or credits will be applied to the card used for the order (allow additional time for refunds/credits on prepaid cards). Access Securepak reserves the right to remove one or more items from the order due to insufficient payment.

**SALES TAX:** Access Securepak® is required by the state of Virginia to collect sales tax on select merchandise and processing fees. All facilities have a sales tax rate of 2.5% on food. All facilities have a 5.3% sales tax on non-food items except for Deerfield Correctional Center, Deerfield Work Center for Men, Deerfield Work Center for Wennen, Indian Creek Correctional Center and St. Brides Correctional Unit who have a 6% sales tax rate. Processing fees have a sales tax of 2.5% when only food items are purchased and 5.3% (or 6% for those select facilities) when non-food items are purchased. Tax calculation example:

\$63.52 merchandise total + \$2.95 processing fee = \$66.47 subtotal \$66.47 subtotal x 0.053 tax rate = \$3.52 tax total

\$66.47 subtotal + \$3.52 tax = \$69.99 total due



**ELIGIBILITY:** Access Securepak verifies inmate eligibility before shipping packages, if applicable.

**LIMITS:** Maximum \$75 of food products per inmate and quantity limits on clothing items. Multiple packages can be ordered, and we will consolidate orders not to exceed the maximum limits defined by the program.
