Tax calculation example:  
\$63.52 merchandise total + \$2.50 processing fee = \$66.02 subtotal  
\$66.02 subtotal x 0.053 tax rate = \$3.50 tax total  
\$66.02 subtotal + \$3.50 tax = \$69.52 total due
